As regards the proposal on the parliamentary oversight on CFSP / CSDP I would like to inform you that the matter is currently under discussion amongst the Foreign Affairs, National Defense and European Affairs Parliamentary Committees. The three Committees are drafting a joint proposal of resolution to be adopted at plenary level, most likely before the EU Speakers Conference. Once the resolution is approved, I will promptly share it with you.

However, having in mind your request of remarks on the proposal circulated amongst the Speakers and the deadline for doing so, I would like to extend my support to substance items 1, 4, 7, 8 and 10 and offer you, at this stage, the following general comments on the remaining topics (please note I stick to the numeracy of your proposal, disregarding number 2 is absent):

- Nr.3 - The total figure of delegates from the European parliament shall not exceed its actual proportion of representation at the COSAC meetings.
- Nr. 5 – Meeting of the Conference on CFSP / CSDP are organized twice a year in the country holding the rotating Council Presidency.
- Nr. 6 – The current model of presidency of COSAC meetings, shall be adopted for the CFSP / CSDP Conferences.
- Nr. 9 – The secretariat of the Conference shall be provided by the existing Secretariat of COSAC, which might be reinforced, if required.
